Guidelines for payment of fees

Payment terms for Prep to Year 12

Accounts for School fees are forwarded to parents four times a year (or at such time as the School otherwise determines).

Annual payment in full — The School offers a 4% discount on full fee paying student tuition fees if the annualised amount is paid on or before 30 November 2018.

Payment by Term — Fees must be paid by the due dates to avoid either an overdue interest charge or an administration fee at the School's discretion.

Payment by authorised instalment — Fees must be paid in ten equal instalments, one payment in each consecutive month commencing from the month in which Term 1 fees are due (30 November 2018).

Discounts

Third Child — Where three or more siblings are attending the School, a discount of 20% off the Tuition fee component will apply for the third or subsequent child(ren). No other concession will apply. This does not apply to Pre-School and Kindergarten.

PJV — The School will match PJV Congregational membership discount up to a maximum of \$945 per family once per year upon production of the PJV receipt to the Finance team. No other concession will apply.

Payment terms for Pre-School & Kindergarten

Accounts are forwarded to families on a fortnightly basis after which the nominated account will be debited.

Please note:

For all accounts across the School, should the account exceed our trading terms and be passed over for collection, all costs including agency commission, solicitors' fees and any out of pocket expenses will be the liability of the parents.

Processing Fee — A charge of \$50 will apply to each cheque, credit card or debit card payment which fails.

Overdue Accounts — Interest on overdue accounts may be charged at the annual rate fixed under the Penalty Interest Rate Act plus 2% or an administration fee at the School's discretion.
