## NOTICE OF SPECIAL GENERAL MEETING - THE KING DAVID SCHOOL HOLDINGS LTD

The King David School Council ('Council') is the governing body of The King David School. Its main role is to formulate and administer the School's policies, direct the School's finances and represent the School in the broader community. This includes raising funds through public appeals. Various subcommittees of Council operate and parents who have specific interests or skills are encouraged to join these sub-committees. The composition and operating guidelines of Council are governed by the Constitution.

Council has completed a substantive review of its governance structure over the past several years. This was largely as a result of Council wanting a modern and functional constitution, to ensure that the School implements best practice corporate governance and to protect the interests of all stakeholders.

Over the past 40 years the School has grown substantially and Council recognised that the current governing arrangements (largely through an unincorporated association) are outdated and does not fit where the School is at in 2020 and beyond. Council recognised the importance of modernising the governance structure and enshrining in the constitution the fundamental principles and objectives of the School that have been set and refined by stakeholders over the last 40 years.

Accordingly, Council has recently adopted a draft new constitution to replace the current constitution with the adoption of the draft new constitution will be the subject of the Special General Meeting which will take place directly after the Annual General Meeting of The King David School and King David Jewish School Limited.

The proposed draft constitution is designed to:

- ensure that the School has a modern constitution;
- ensure that the activities of the School are contained within a corporation (rather than an unincorporated association);
- enshrine into the constitution that the School is based upon the values of Progressive Judaism;
- have a limited number of members (up to 18) that will determine the composition of Council and any future amendment of the constitution.

Council is of the view that the draft new constitution will protect the interests of the School and allow the School to continue to develop and grow, whilst retaining the important principles and objectives that guide the School. Council supports the adoption of the draft new constitution.

# 3 Voting and required majority

- (a) In accordance with section 9 of the *Corporations Act 2001* (**Act**) and the current Constitution of the Company for the special resolution to be effective -
  - (i) at least 14 days' notice of the Special General Meeting must be given; and
  - (ii) the special resolution must be passed by at least 75% of the votes cast by members present and entitled to vote on the special resolution.
- (b) On a show of hands, and on a poll, every member has one vote.

Each member who is over the age of 18 and has paid all subscriptions and any other moneys due and payable to the Company is entitled to attend and vote at this Special General Meeting.
